The main focus of the Society is to be in the information arm for the industry. The board has chosen issues that have a huge impact on the future of the industry.

MEET DR. ALAN SAMS, DEAN OF THE OSU COLLEGE OF AGRICULTURAL SCIENCES

Very new at this particular endeavor, Dr. Sams has agreed to attend the morning session of our annual meeting. Several folks from the industry have had opportunity to visit with Dr. Sams and are excited about working with him to build on our continued partnership with OSU.

CHINA TARIFF SITUATION

Many growers do not likely realize all the footwork that has been done since the announcements of increased tariffs for hazelnuts destined for China. There has been a constant unwavering effort to keep communication lines between the industry, the people of China and the U.S. administration open with the hope that this hard work will pay off with a lower tariff in the end. Concurrently, office staff have worked diligently to ensure the hazelnut industry is included in any federal programs designed to help commodities dependent on China. Meredith and Larry have agreed to expand on these areas.

HAZELNUT PRICES 2018

The hazelnut price determination is always of interest to every grower. HGBA Executive Terry Ross will provide the details of hazelnut price discovery 2018. While each year has its unique factors, 2018 definitely included a combination of issues never before encountered.

We hear a lot of talk about what the Marketing Board is doing to promote hazelnuts as the industry grows. Not only do we have a new research study just released, but we are also in the midst of one of the largest promotion years on record. 
EMPHASIS ON PRODUCTION PRACTICES TO INCREASE TONNAGE OF "GOOD NUTS"

Nurserymen are the Key to Keeping Hazelnut Varieties Pure

If you are a grower choosing where to purchase hazelnut trees, it is imperative that you go through a licensed nursery to ensure you are getting the variety you want. Whether the trees you want are older or newer varieties, all nurseries must have an Oregon Department of Agriculture (ODA) nursery license in order to sell trees. To ensure your investment is in the varieties you want, ask for the license number or go to the ODA website to if your nursery is on their list. If you are propagating trees for your own use, you also need to have an ODA license.

Protected Varieties: If you are a grower propagating trees for your own orchard, a nursery or a micropropagator and you are selling PollyO, McDonald, Wepster, York, Doris, Felix or Burgundy Lace, you will also need a license for each cultivar from the OSU Office of Commercialization and Corporate Development (OSU-OCCD). With the two licenses, plant material can be obtained from the OSU hazelnut breeding program, or another licensed nursery.

Paying Royalties: If you are propagating the protected varieties as a nursery (including for your own use), or as a micropropagator you are responsible for collecting royalties when you transfer trees to an end user who plants them in an orchard. Licensed nurseries propagating trees for their own orchards are responsible for payment of royalties directly to OSU-OCCD. For transfer of plants of patented cultivars from one micropropagtor or nursery to another, no royalty is collected provided they both have licensing. Royalties are paid to OSU-OCCD.

It is important for a nursery to qualify their customers. Licenses from OSU-OCCD for protected varieties limit sales to the United States. Permission to sell to customers in other countries requires approval from OSU-OCCD.


